

**ORDINANCE NO. 2017-2**

**AN ORDINANCE REQUIRING A MOVING PERMIT BEFORE ANY  
MOBILE HOME CAN BE PERMANENTLY MOVED INTO THE CITY OF  
LOCKESBURG, ARKANSAS**

**WHEREAS**, the City Council of the City of Lockesburg, Arkansas has determined that there is a great need for a moving permit to be obtained prior to any mobile home being moved permanently into the City of Lockesburg, Arkansas;

**WHEREAS**, the purpose of this Ordinance is to protect the health, safety and welfare of all residents of the City of Lockesburg, Arkansas;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Lockesburg, Arkansas;

**Section 1.** That before any mobile home shall be moved into the City of Lockesburg, Arkansas, a moving permit shall be first obtained by any person or any mobile home moving company prior to a mobile home being moved permanently into the City of Lockesburg, Arkansas.

**Section 2.** That said moving permit shall be issued by the City Clerk of Lockesburg, Arkansas, after a moving permit application has been approved by the City Council of Lockesburg, Arkansas. That a nonrefundable application fee of \$100.00 payable to the City of Lockesburg, Arkansas shall be paid before any moving permit is issued.

**Section 3.** That before any mobile home moving permit is issued, the Mayor or any other City Official as designated by the Mayor of Lockesburg, shall inspect such mobile home to ensure that the subject mobile home meets the requirements as set forth in the City of Lockesburg Arkansas Ordinance No. 2008-2.

**Section 4.** That no mobile home shall be moved into the City of Lockesburg, Arkansas until all requirements of this Ordinance have been complied with and a Moving

Permit is obtained by the person or persons wishing to permanently move a mobile home into the City of Lockesburg, Arkansas.


**Section 5.** That failure to comply with this Ordinance shall be a criminal offense and shall be punishable by up to a fee of \$25 per day that said Ordinance is violated.

**Section 6.** It is hereby ascertained and declared that there is a great need to require a moving permit be obtained before any mobile home is permanently moved into the City of Lockesburg in order to promote and protect health, safety and welfare of the City and its inhabitants. It is, therefore, declared that an emergency exists and this Ordinance being necessary for the immediate preservation of public peace, health, and safety shall be in force and take effect immediately from and after its passage.


**Section 7.** Until all provisions of this ordinance and ordinance No. 2008-2 have been complied with, the City of Lockesburg, Arkansas shall not connect the newly moved mobile home to any city utilities including water and/or sewer service.

**Section 8.** That all ordinances and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.
